1. 2. You will need to fill out and submit the **SLFS Application for Assistance (F-001)** via email to **slfsdirectors@gmail.com**.
3. You will need to sign an **SLFS Waiver of Liability Form (F-002)**, which states that SLFS cannot be held liable for any problems which may arise as a result of our advice or assistance.
4. You will be notified when we receive your application and further information may be requested. We look at your application and determine whether it meets the basic requirements for an eligible case.
5. If the **Board of Directors of the SLFS (Board)** feels that your case meets the mandate of the Society and has a possibility of proceeding, the Board will pass the case on to the **SLFS Litigation Committee (LitComm)** for an opinion.
6. Your signing of the **SLFS Funding Application (F-003)** grants SLFS the right to obtain legal advice on your behalf in order for LitComm to advise the SLFS Board on the probability of success of the case.
7. The Board will then decide whether to offer you funding based on its consideration of the legal aspects of the case and funding criteria as outlined above. If not offered funding, we will inform you of the reasons.
8. We will then communicate the Board's decision. If you have been granted funding, we include a **Funding Agreement (A-001)** for you to sign.
